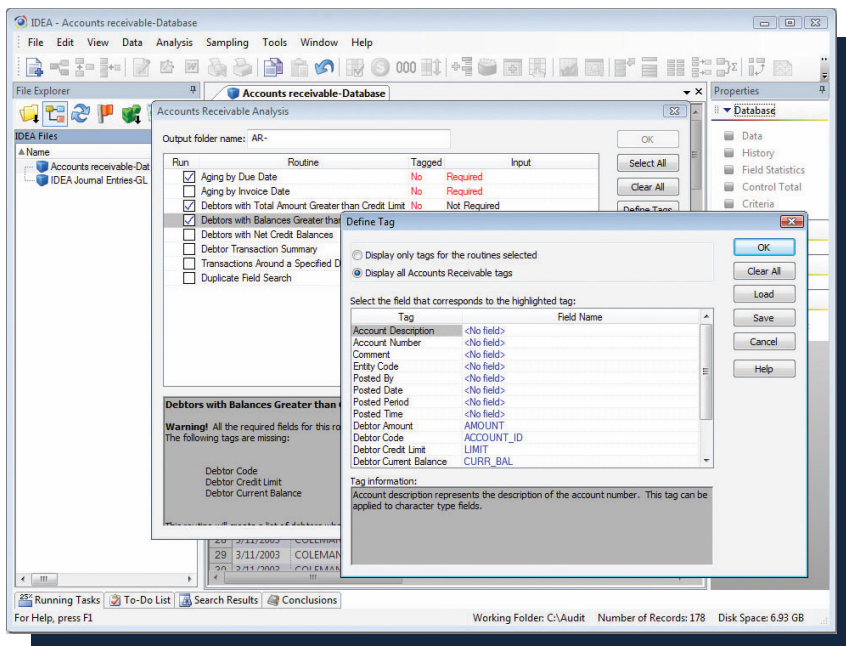

## A Simple Process

Using IDEA Smart Analyzer is a simple, four-step process.

### Step 1:

Import client data files using one of IDEA's many predefined formats or use the Import Assistant to guide you through the process. You can also use IDEA's Report Reader to import data contained in reports printed to file or Adobe PDF.

### Step 2:

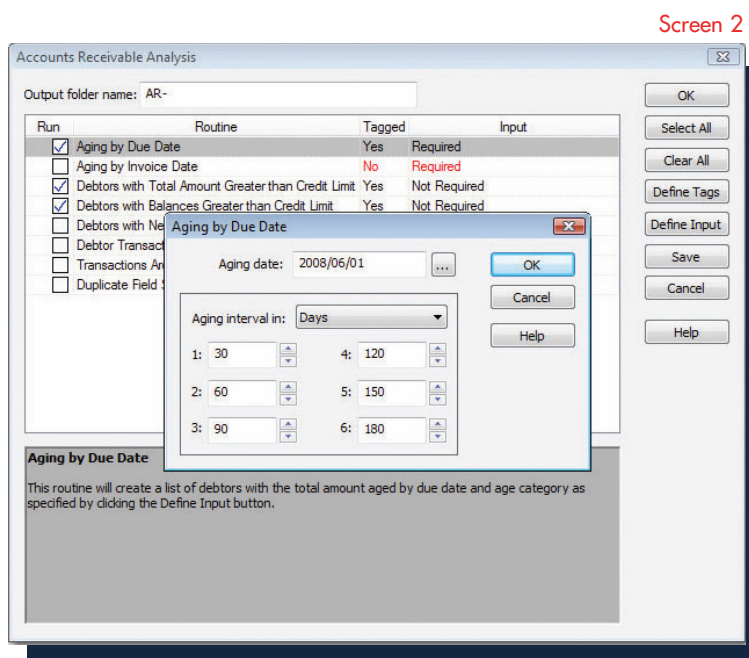
Select the tests you want to run and IDEA Smart Analyzer will intelligently identify the tags required to run the selected tests (Screen 1).

### Step 3:

Tag the data using IDEA Smart Analyzer's intuitive interface. In some cases, you will be asked for additional information such as a date range (Screen 2).

### Step 4:

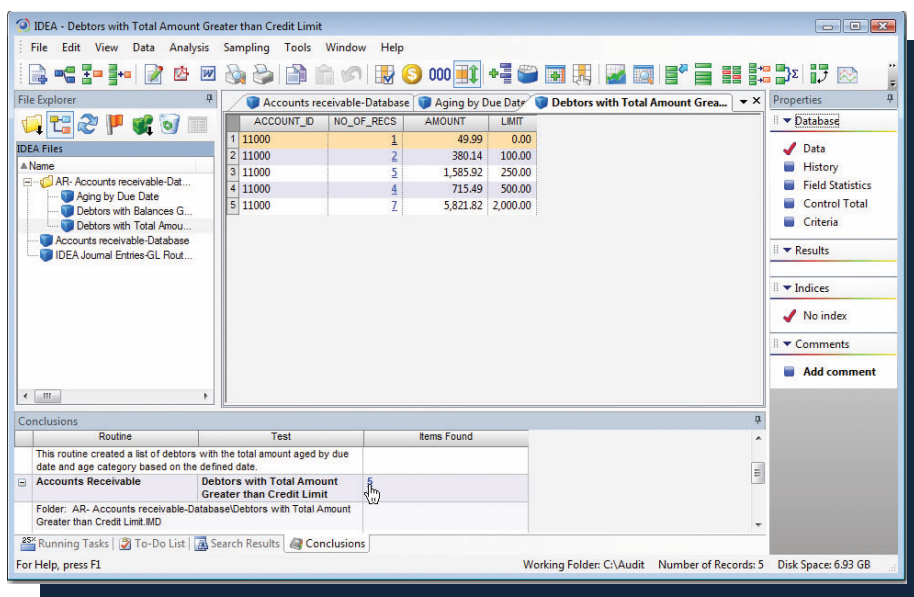
Press OK and review the results in Conclusions fly-out window (Screen 3).
